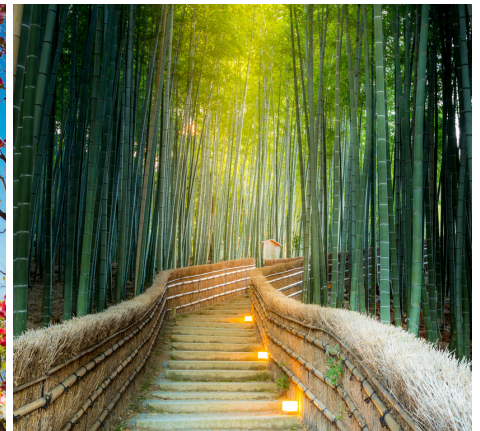

ARRIVAL IN OSAKA
